The members of the Board of the Lancaster County Land Bank Authority met Tuesday, September 26, 2023. The Board meeting was held at the offices of the Lancaster County Housing & Redevelopment Authorities, 28 Penn Square, Lancaster, and via Zoom Videoconference.

Staff Reports: Mr. Krumpe reported that the Land Bank has 7 ongoing projects, 5 are in Columbia Borough. The project in Denver is approved for demolition. Mr. Williams inquired about the slow process in the Manheim project. Mr. Krumpe noted that it was due to a review that was needed for the sprinkler system, but it should start to move forward again now.

Mr. Jim Eby joined and assumed control of the meeting.

The Financial Reports for July and August 2023 were approved on a motion by Mr. Robinson, second by Mr. Fisher, and unanimously accepted. Mr. Fredo introduced the Finance and Administration Manager, John Hursh, who prepared these reports this month. Mr. Hursh noted that the report for August had a lot of catching up on accounts from the Redevelopment Authority.
