## 4. Permits and work Standards.

Contractor is responsible for ensuring that the work meets all applicable federal, state, and local building and health codes. Contractor is responsible for obtaining permits required for work performed.

## 5. Scope of Work

Mobilize on-site and set up OSHA-compliant safety equipment. 100% Tie-off beyond warning flag system.

Mark all below deck conduit onto roof surface.

Provide and install .50 mil Duro-Tuff PVC membrane over Duro-Weave slip sheet insulation in accordance with the manufacturer's specifications and details for a mechanically attached roof system.

All parapet wall materials to be adhered or mechanically fastened to substrate.

Provide and install manufacturer provided 24-gauge steel Two-Piece compression metal for parapet walls, in standard color, coping.

Provide and install all needed vinyl termination bar around curbs, large round penetrations and at block/concrete walls.

Provide and install color matched prefabricated stack and curb flashings. Round penetration flashings terminated with stainless steel banding and Dura-Caulk.

Provide and install color matched Two-Way vents one per 1000 sf of membrane in accordance with manufacturer's specifications.

Complete installation of all materials and remove all contractor generated debris.

include the membrane manufacturer's standard 20 Year No Dollar Limit Labor and material warranty, as well as two-year Workmanship warranty.

Includes all sales tax, hoisting, and disposal equipment required to complete this scope of Work.

#### 6. Insurance

Contractor will provide proof of Insurance with a certificate naming the Redevelopment Authority of the County of Lancaster as an additional insured.

#### 7. Performance Bond

Lancaster County Redevelopment Authority requires the Contractor to provide a performance bond in a sum not less than the amount of the contract as awarded.

## 8. Completion date

This bid must include expected start and completion date as to minimally interfere with scheduled ballpark baseball season.
