Mr. Martin asked for clarification on the property owner as they have been confirmed to be living in an assisted living facility. The certified mail has been signed for, but not responded to. Mr. Heiserman suggested a visit to the facility. Mr. Eby said we would need to discuss this with our solicitor. Mr. Hess

made a motion to approve the second determination of blight resolution, Ms. Zink seconded, and it was approved.
