The members of the Board of the Lancaster County Land Bank Authority met Tuesday, September 24, 2024. The Board meeting was held at the offices of the Lancaster County Housing & Redevelopment Authorities, 28 Penn Square, Lancaster, and via Zoom Videoconference.

Staff Reports: Mr. Krumpe noted the Denver project is continuing. There is a slight delay with the Manheim Fire House construction, but it is nearly completed and the board is welcome to visit. Mr. Krumpe showed before and after photos of the 612 Franklin Street and 318 Poplar Street properties in Columbia. Mr. Jim Eby is very impressed with the design of the 612 Franklin Street home. The 318 Poplar Street home will be sold to a 1st time home-buyer working with Tenfold.

Mr. Krumpe is working on a Blight Reporting Tool. This web-based tool will be open to the public and will hopefully speed up the process to identify and restore blighted properties. Mr. Jim Eby asked how this will be marketed, and it is still early in the process, but they intend to have flyers and general outreach. Mr. Stuhldreher recommended connecting with the "Fix It" city tool, the Planning Commission and the local TV stations to help get the word out. Mr. Fisher is concerned about getting overwhelmed with properties. They will closely monitor and can shut it down if necessary.

The Financial Report for August 2024 was approved on a motion by Mr. Fisher, second by Ms. Kaufman, and unanimously accepted. Mr. Fredo noted that all of the income was from interest.
