The members of the Board of the Lancaster County Housing Authority met Tuesday, September 23, 2025. The Board meeting was held at the offices of the Lancaster County Housing & Redevelopment Authorities, 28 Penn Square, Suite 100, and via Zoom Videoconference.

Members of the Board in attendance: Ed Fisher, Melinda Kaufman, Mike McGee and Jim Williams.

Staff members present were: Justin Eby, Executive Director; Audrey Steinmetz, Director Tenant and Landlord Services; Deb Jones, Director of Human Services; Marisol Maldonado, Director of Housing and Community Development; Scott Fredo, Director of Administration and Finance; Rachel Valmonte, Compliance Manager and Beth Dreyer-DeGoede, Secretary.

Also in attendance: Rhonda Harrison, Lancaster Redevelopment Fund board member.

Mr. Fisher called the meeting to order at 4:07 p.m.

Public Comment - None

Minutes of the June 2025 meeting were approved. The motion was made by Mr. Williams, second by Ms. Kaufman and unanimously accepted.

Communications – Mr. Eby noted that the Housing Authority has a close out audit meeting with the US Treasury on Friday, September 26.

Staff Reports – Mr. Eby reported that the September 30, 2025 is the end of the Emergency Rental Assistance Program (ERAP). No payouts can be made for expenditures after that date.

The Monthly Activity and Status Report is attached hereto and made a part hereof.

The Financial Reports for the months of June, July and August 2025 were approved on a motion by Ms. Kaufman, second by Mr. Williams and unanimously accepted. Mr. Fredo noted that June has \$3.4 million of ERAP funds received and paid to HDC. July had no activity. For August, he noted that fraud recovery was up 22% from the prior year and commended the Housing Authority staff for this improvement. Mr. McGee asked what this meant. Ms. Steinmetz said that they follow up with voucher holders to make sure that they are in compliance and pay back if they need to. Mr. Fredo also noted that they had \$1.3 remaining in ERAP funds but will be down to approximately \$80,000 after payments this week. Mr. Fisher asked how the Housing Authority could move the number of vouchers disbursed but not leased up down. Ms. Steinmetz said that the barrier is finding landlords who will accept the vouchers.

Committee Reports - None

New Business:

2) The board adopted the Annual Plan for Fiscal Year 2026. Ms. Steimetz noted there were 7 Foster to Youth Independence Vouchers but 2026, but no other new vouchers. NOW, THEREFORE, BE IT RESOLVED, by the Board of the Lancaster County Housing Authority, to adopt the Annual Plan for the upcoming fiscal year; and

BE IT FURTHER RESOLVED to authorize the Chairman to sign "Certification by State or Local Officials of PHA Plan's Consistency with the Consolidated Plan," required for submission of the Annual Plan for Fiscal Year 2026 to the U.S. Department of Housing and Urban Development.
